With the April 14, 2003 deadline looming to comply with the HIPAA Final Privacy Regulations, employers and other health plan sponsors, health plans, healthcare clearinghouses and health care providers alike are scrambling to develop a workable, financially viable compliance strategy to respond to the Final Privacy Regulations.
